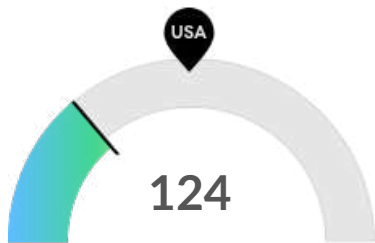

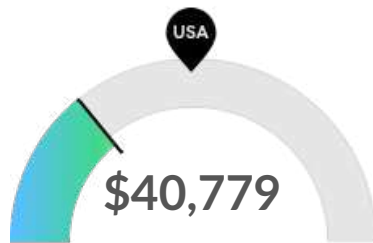

Light Job Posting Demand Over a Thin Supply of Regional Jobs



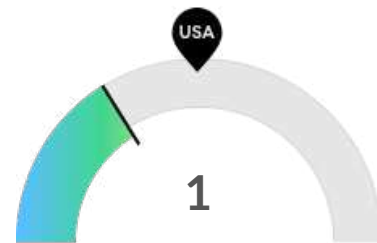
Jobs (2023)

Job Posting Demand

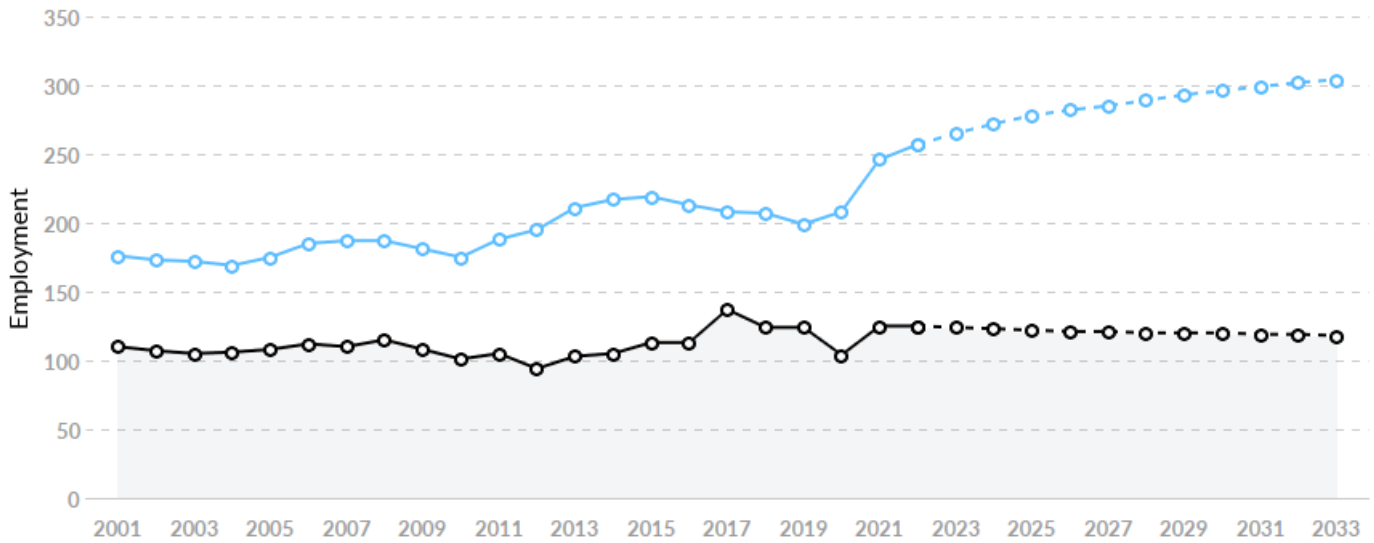

Regional Employment Is Lower Than the National Average

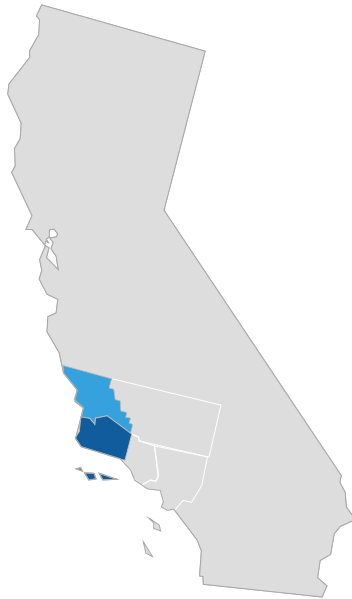

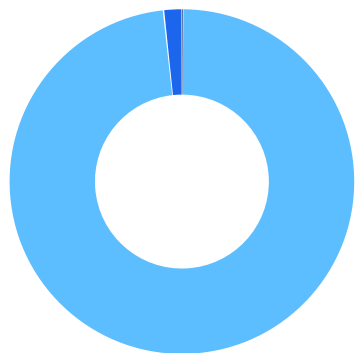

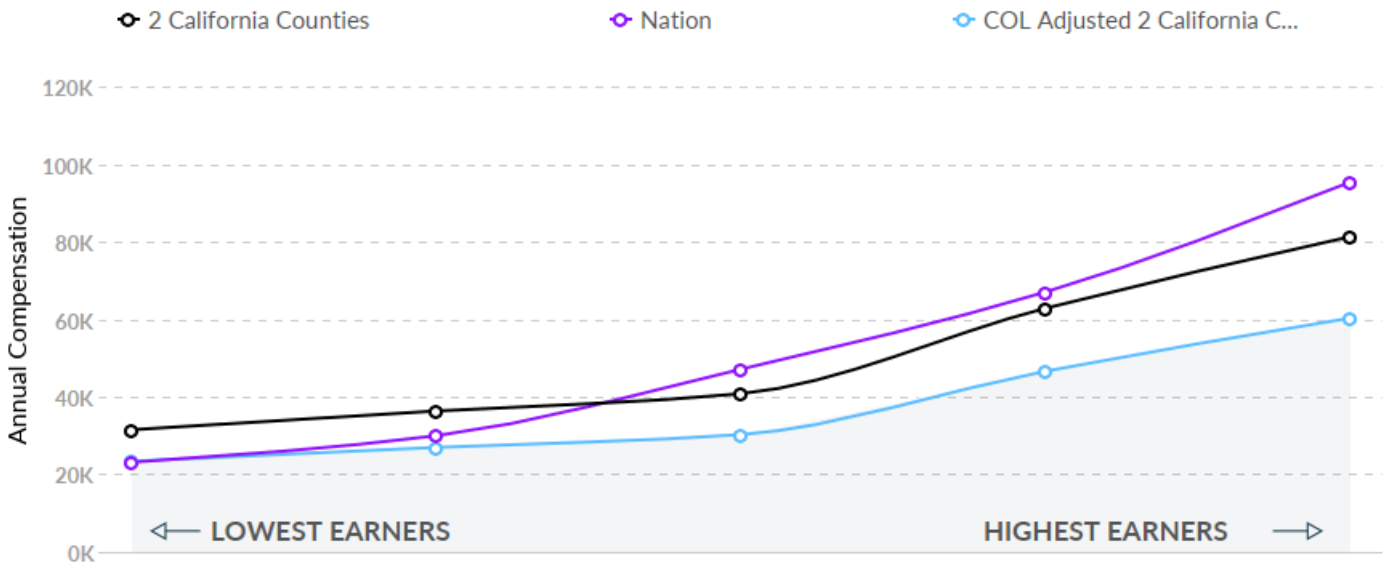

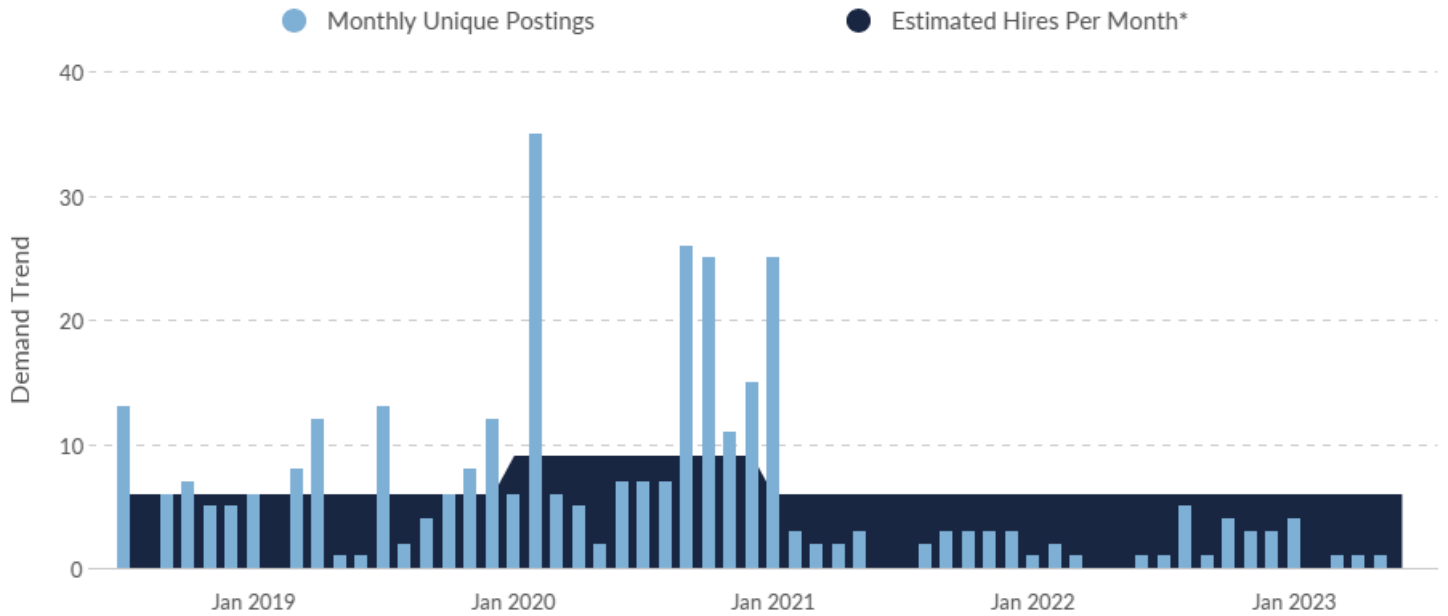

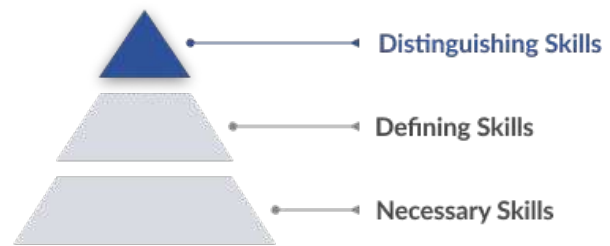

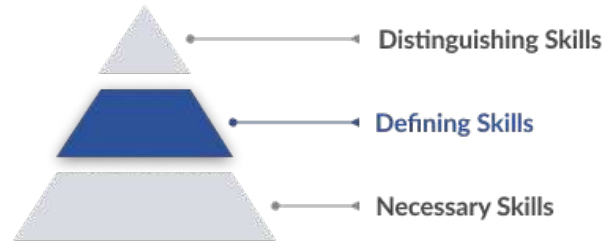

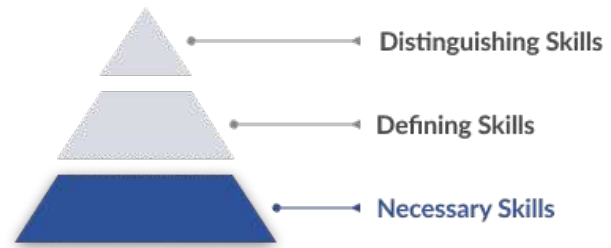

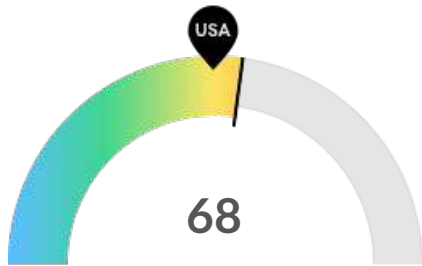

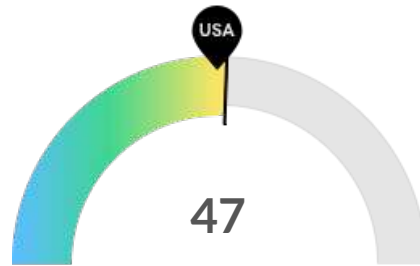

Retirement Risk Is High, While Overall Diversity Is About Average



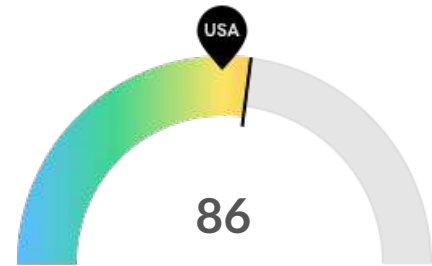
Retiring Soon

Racial diversity is about average in your area. The national average for an area this size is 45* racially diverse employees, while there are 47 here.

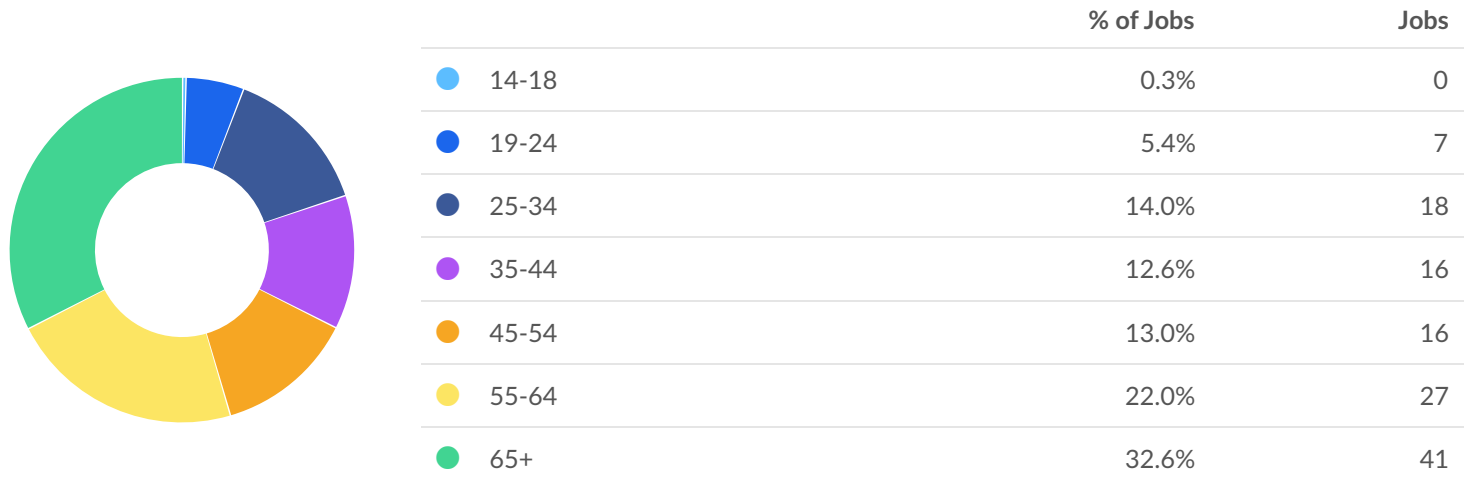


Gender Diversity

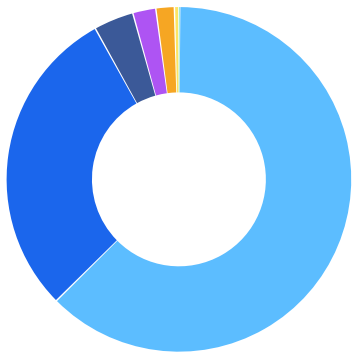

Occupation Age Breakdown

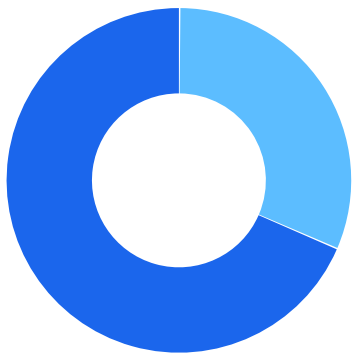

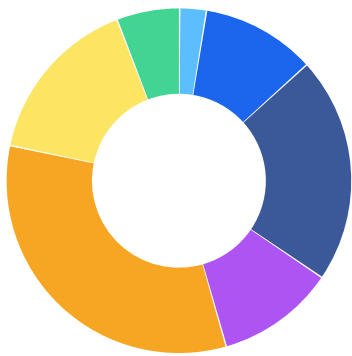
