Reports and Discussions [Non-action Items]

7. AI Summit Update [5] (NJW)

Discussion: A. GDT and N. Ward provided a brief update on the registration for the upcoming summit that consisted of students, faculty, administrators, high school students, and others. They highlighted the various activities during the summit including an AI and Art pop-up Exhibition.

8. DE Survey [10] (FP/ E. Biely)

Discussion: Erica B. highlighted the respondents of the recent DE survey conducted in the fall of 2024. The survey was sent to faculty, students, and administrators. The topics were teaching, online offering, experiences with DE modalities, use and access to virtual exchange, artificial intelligence (AI), etc. Faculty DE challenges included academic dishonesty, lack of engagement, unable to address student needs, etc. The students echoed similar challenges. The data will be sent when made available by the CCCC. C. Bach stated the survey was lengthy and burdensome and provided insights regarding data interpretation.

- The data is still pending from the CCCC. Whether the data can be disaggregated remains to be determined.
- There were suggestions to adopt a similar survey or parts of the survey in the college.

10. Dual Enrollment/ CCAP Update [10] (T. Lamica)

Discussion: T. Lamica provided an overview of the current state of AHC courses in the local high school partners and enrollment projections for 2025-26. The college has moved from a non-CCAP model to a CCAP model (AB 288: College and Career Access Pathway Act).

- CCAP refers to College and Career Preparation Pathways.
- College course offerings in high schools are regardless of whether the offering is on the bell schedule or outside the bell schedule.
- AHC will no longer have a “College Now” designation of courses. All courses are open to high schools unless there are identified restrictions. Larry M. mentioned that the AP&P Committee is working on an “opt out” process.
- The annual approval for course offerings in high schools goes through an approval process of about six months that includes faculty and department, vetting of the faculty teaching the course in the local high school, and MOU between the college and high school.
- There are different sets of needs associated with the CCAP that include but are not limited to catalog rights, different student needs, equipment and resources, counseling, tutoring, and impact on AHC enrollment and faculty.
