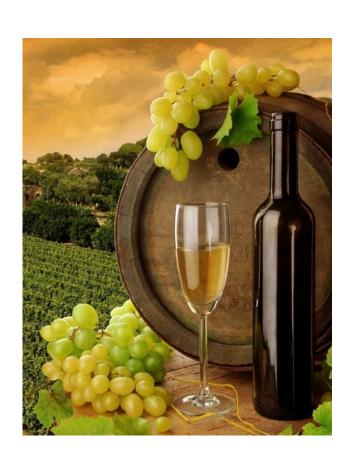

1. Call to Order

Alfredo Koch called the meeting to order at 4:05 p.m. with the following present: Alfredo Koch, Michael Black, Kevin G. Walthers

2. Public Comment

3. Action Items

3.A. Approval of May 21, 2015 Meeting Minutes

On a motion by Kevin Walthers, seconded by Michael Black, the Foundation board voted to approve the minutes for the May 21, 2015 board meeting as submitted. (Ayes: Black, Koch, Walthers; Noes: None; Absent: Lahr)

3.B. Vineyard Lease Agreement

On a motion by Kevin Walthers, seconded by Michael Black, the Foundation board approved a four-acre vineyard ground lease agreement between the Allan Hancock College Joint Community College District and the Allan Hancock College Viticulture and Enology Foundation for a nominal fee. (Ayes: Black, Koch, Walthers; Noes: None; Absent: Lahr)

3.C. Wholesale Wine

On a motion by Kevin Walthers, seconded by Michael Black, the Foundation board set wholesale wine pricing at 60 percent of price list. (Ayes: Black, Koch, Walthers; Noes: None; Absent: Lahr)

3.D. Amended Master Operating Agreement

On a motion by Kevin Walthers, seconded by Michael Black, the Foundation board amended the Master Operating Agreement as submitted. (Ayes: Black, Koch, Walthers; Noes: None; Absent: Lahr)

3.E. CoastHills Credit Union Agribusiness Student Scholarships

On a motion by Kevin Walthers, seconded by Michael Black, the Foundation board established two agribusiness scholarships in the amount of \$1,250 each for 2015-2016 and two agribusiness scholarships in the amount of \$1,250 each for 2016-2017. 3.F. Board Member Election

The Foundation board acknowledged Dominic Dal Bello, interim dean of academic affairs, as a member and secretary to the Foundation Board of Directors. (Ayes: Black, Koch, Walthers; Noes: None; Absent: Lahr)

4. Information Items

4. A. Financial Report

Michael Black reviewed the balance sheet and the income statement for the Allan Hancock College Viticulture and Enology Foundation for the period ending October 31, 2015.

4. B. Winery Name

Alfredo Koch shared the reasons he feels it's necessary to give the Allan Hancock College winery a name. He said the Foundation has discussed various names that could serve as a brand name. The brand name could be used for logos, and promotional items such as t-shirts, hats, and stickers. Dr. Walthers suggested working with Public Affairs to solicit suggestions for the winery to be forwarded to the Foundation for consideration.

4. C. Donation Report

Alfredo Koch reported the Viticulture and Enology Foundation received a donation of \$55,000 from CoastHills Credit Union. In addition, Dr. Walthers reported CoastHills has agreed to make the college the recipient of next year's Rancho Vino fundraising event.

4. D. Credit Card Authorization

Alfredo Koch explained the Viticulture and Enology Foundation is in need of a credit card. He explained the wine industry deals with live plants and due to this there are time is limited and in some circumstances emergency materials are needed. He noted staff has had to buy materials with their own money and be reimbursed later. He explained a credit card would make this process easier.

4. E. Insurance Coverage for the AHC Viticulture & Enology Foundation

Michael Black explained the foundation's insurance coverage in the event of robbery or disaster. He said the foundation's insurance liability deductible is \$10,000 and would insure up to \$250,000.

5. New Business

Carmen Camacho mentioned the conflict of interest policy recently approved requires follow up.

Dr. Walthers suggested providing a report on the winery inventory for the next meeting.

Alfredo Koch explained a consultant from Australia is arriving on January 12, 2016. He noted the consultant is a world famous speaker on viticulture.

BACKGROUND

The Allan Hancock College Public Affairs office provided the following contest update.
